



## Privacy Policy

Lima One Capital, LLC and its affiliates and subsidiaries (collectively referred to as **“Company”**, **“we”**, **“us”**, and **“our”**) respect your privacy and are committed to protecting it through our compliance with this privacy policy (**“Privacy Policy”**). This Privacy Policy describes the types of information we may collect from you or that you may provide when you visit our website [www.limaone.com](http://www.limaone.com) (our **“Website”**) and our practices for collecting, using, maintaining, protecting, and disclosing that information. Our Website was created to provide information about the Company and our real estate lending services, mobile applications, and related services (the **“Services”**).

This Privacy Policy applies to information we collect through our Website, Services, and in email, text, and other electronic messages between you and this Website, and when you interact with our advertising and applications on third-party websites and services. It does not apply to information collected by any third party, including through any application or content (including advertising) that may link to or be accessible from or on the Website.

### Information We Collect About You and How We Collect It

When you interact with us this through our Website and related Services, we collect several types of information from and about users of our Website. We may collect such information directly from you when you provide it to us, automatically as you navigate through the Website, and from third parties (e.g., our business partners).

The information we collect includes information by which you may be personally identified, such as name, postal address, email address, telephone number, social security number or any other identifier by which you may be contacted online or offline (“**Personal Information**”). ### ***Information You Provide to Us***

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

The information we collect automatically is only statistical data and does not include Personal Information, but we may maintain it or associate it with personal information we collect in other ways or receive from third parties. It helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- Store information about your preferences, allowing us to customize our Website according to your individual interests.
- Speed up your searches.
- Recognize you when you return to our Website.

The technologies we use for this automatic data collection may include:

- **Cookies (or browser cookies).** A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.
- **Web Beacons.** Pages of the Website and our emails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the Company, for example, to count users who have visited those pages or opened an email and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

Neither our Website nor our services are intended for individuals under the age of 18. We do not knowingly collect personal information from minors. ## **How We Use Your Information**

To present our Website and its contents to you. We use information that we collect about you or that you provide to us, including any personal information:

- Lima One Capital, LLC may disclose your Personal Information if we believe that we are required to do so (i) to comply with any court order, law, or legal process, including to respond to any government or regulatory request, (ii) to enforce our rights under the Terms of Use and other agreements, including for billing and collection purposes, and (iii) to protect the rights, property or safety of Lima One Capital, LLC, our customers, or the public.

This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.
